# **Press Release**

The Privacy Symposium International Conference will gather in Venice the highest authorities and experts from 5 continents to support International Cooperation on Data Governance, Regulatory Compliance, and Innovative Technologies, such as Artificial Intelligence.

The Privacy and Data Governance Symposium (also known as "Privacy Symposium") is an international conference that aims at supporting international dialogue, cooperation, and knowledge sharing on data governance, regulatory compliance, and innovative technologies. From May 12 to 16, 2025, it will offer over 100 thematic sessions and will give the floor to over 300 top-level speakers and authorities in Venice, Italy.

The conference will bring together the highest authorities in the domain of data regulation, including international organisations (Council of Europe, OECD, World Bank, ICRC, United Nations - UNESCO, WFP, IMF, etc.), the <u>European Union</u> (EDPB, EDPS, FRA, DG Justice, DG Santé, Europol), and <u>national authorities</u> (most European national data protection authorities, as well as the U.S., Canada, Mexico, Argentina, Peru, Australia, Kenya, Nigeria, Senegal), <u>expert researchers</u>, <u>industry representatives</u> as well as the <u>EU Commissioner for Democracy</u>, <u>Justice</u>, and the Rule of Law and the UN Special Rapporteur on the Right to Privacy.

The programme of the conference will cover several tracks, including:

- Freedom of Expression and Data Regulation;
- International Cooperation, focusing on global convergence in data regulations, enforcement, and international standards;
- Artificial Intelligence Policies and Regulations;
- Technology and Compliance, discussing innovative technologies such as satellite communications, geolocation data, trusted cloud criteria, and digital identities;
- Data Protection in Practice, with guidance and clarifications from authorities and experts;
- DPO Cooperation, discussing the evolution of DPO roles, capacity building, and cooperation;
- Making Data Secure, with a focus on threats and security of personal data;
- Socio-Economic Perspective, with a focus on turning compliance into value creation;
- Health and Medical Data Regulation and Compliance, including for secondary use of data;
- Accountability, Trust, and Privacy-Enhancing Technologies (PET), with a focus on international data protection certification;
- Research and Innovation, with latest research results and achievements;
- Data Protection in Italy (presented in Italian);
- Deep Dive In Sessions focused on practical capacity building sessions for professionals;

 Scientific Track with presentations of selected papers from the Privacy Symposium Call for Papers.
